PAYMENT METHODS FOR AFJ REGISTRATION FEE & SPOUSE/GUEST FEES

1. **Checks** should be drafted on a United States bank payable to AFJ. There will be a \$50 (USD) surcharge on insufficient funds checks. Checks on non-United States banks will not be accepted; use the Credit Card Authorization Form. If the completed registration form and the check cannot be sent together, be sure the check indicates the name of the registered person. If your publication's accounting department needs AFJ's tax number, it is 23-7324877. AFJ is a tax-exempt nonprofit corporation.
2. **Credit Card Authorization Form** payments are subject to a \$10 transaction fee except for those living outside of the United States who must use the Credit Card Authorization Form and cannot send payment on a non-U.S. bank. All information requested on the form must be given. Forms are shredded after processing.
